a) 2015-11.1 Engine Replacement – Request for Decision

Martin Bean – Update on engine status. Nova and Cummins say unusual catastrophic engine failure.

Martin Bean – Up to 14 weeks for engine replacement however alternatives are being sourced Karen Sorensen - Funds are coming from 2019 capital because of allocation.

Dave Schebek – Rebuild Engine timing and cost.

Sean Krausert – How are we with spare ratio.

Sean Krausert motion funds are brought forward from 2019 capital in order that funds are available to replace the engine on Moose bus
